Welcome to the first quarterly National Diabetes Prevention Program (National DPP) Coverage Toolkit Bulletin of 2023. This bulletin is released every three months (in February, May, August, and November), and includes a synopsis of the new content that has been published on the National DPP Coverage Toolkit (the Toolkit) and key highlights that demonstrate the impact on its readership. Toolkit updates are developed in alignment with our partners' technical assistance needs, focusing on the information partners need to plan for, operationalize, and sustain payer coverage for the National DPP lifestyle change program.

Here is a summary of Toolkit content updates and analytics from the past quarter, November 2022 - January 2023.

Updated Content and New Features

New Pages

UHA Pages

<u>UHA Overview Page</u> – The <u>UHA Landscape Analysis</u>, a tool to help analyze the rate of prediabetes and the National DPP in a service area, and the <u>UHA Checklist</u>, a tool that outlines tasks for each phase of developing a UHA, were updated to reflect the most current versions. The <u>UHA Resource Guide</u> and accompanying <u>UHA Resources at a Glance</u> document were added to the Overview page. The UHA Resource Guide offers a comprehensive listing of components and topics related to UHAs and the At a Glance document gives a brief summary of what is included in the resource guide. Additionally, the Umbrella Hub Demonstration Section on the Overview page was updated to include Spotlight information documents for the Demonstration sites:

- <u>Hawaii PCA -</u> Focuses on public health infrastructure and Hawaii PCA's experiences working with FQHCs.
- <u>Health Promotion Council</u> Focuses on achieving sustainability through payer reimbursement and HPC's experience becoming an MDPP supplier.
- <u>Marshall University</u> Focuses on the importance of interdepartmental partnerships in operationalizing the UHA.

<u>UHA Business Model Page</u> – The Business Model page was updated to include the <u>UHA Cost Study</u> that was completed with a focus on the three Demonstration organizations. The cost study aims to give estimates of actual cots and cost categories for organizations wanting to operationalize a UHA.

Medicaid Case for Coverage

The <u>Medicaid Case for Coverage</u> page (Stage 1) now includes general descriptions of units (i.e., sections, divisions, departments, etc.) within Medicaid. Different functional units within Medicaid will have a role in implementing the National DPP lifestyle change program as a Medicaid-covered benefit, and connecting with and establishing good working relationships with Medicaid officials in one or more of these areas could help generate movement toward Medicaid coverage.

Various Pages


The Maryland State Story, the Recruitment & Referral, and Screening & Identification pages were updated to include information on how Maryland Medicaid has been working with Chesapeake Regional Information System for our Patients (CRISP), the state designated health information exchange (HIE), to identify individuals eligible for participation in the National DPP lifestyle change program and facilitate referrals through a closed-loop electronic referral process.

Various pages were updated to reflect the changes to the <u>MDPP 2023 rates</u>. Additionally, the Budget Projection Template <u>Medicaid</u> and <u>Commercial</u> Instructions and <u>Budget Projection Template</u> were updated to reflect the new rates.

Coverage Toolkit Website Analytics and Usage



Context:

- Baseline numbers are based on $^{\sim}5$ years of data and all other columns correspond with quarterly reporting in year five (8/1/22 7/31/23) of a five-year cooperative agreement between CDC and NACDD (i.e., 'Y5 Q1' is 8/1/22 10/31/22 and 'Through Y5 Q1' means through 10/31/22)
- Unique Users (used to be called 'visits') are calculated for all who have initiated at least one session and could include return visitors using different devices or those who have cleared their cookie.
